INSTRUCTIONS FOR USE OF DEALER OR MANUFACTURER NUMBERS

- 1. Dealer and Manufacturer numbers shall be displayed on a removable plaque measuring approximately 24" X 4" in size.
- 2. All numbers shall be displayed in the proper sequence with a current year validation sticker.
- 3. Numbers shall only be temporarily attached to a vessel during demonstration or test and are valid for that period only.
- 4. Dealer and Manufacturer numbers are nontransferable and are no longer valid upon sale or termination of business.
- 5. Numbers not renewed by December 31 will be cancelled. A Certificate of Non-Operation will not be accepted.
