## Issue Date: March 8, 2024

### **New Information**

In support of the Strategic Highway Safety Plan (SHSP) and to significantly reduce fatal or serious injury traffic accidents, the Department of Motor Vehicles (DMV) encourages driving schools to include additional video content related to vulnerable road users (VRUs) in their existing curriculums. Some examples of VRUs include pedestrians, cyclists, and highway/road workers.

Driving schools are **not** required to submit a new curriculum or pay fees to update their curriculum. However, DMV is interested in feedback and requests driving schools to email **DMVPolicyOLCompliance@dmv.ca.gov** if any VRU videos are incorporated.

#### Background

The SHSP is a statewide, coordinated traffic safety plan that provides a comprehensive framework for reducing roadway fatalities and serious injuries on California's public roads. As part of the SHSP, a VRU Safety Assessment was completed that analyzed data gathered from 2011-2021. The assessment determined a steady rise in fatal or serious injury traffic accidents involving VRUs and highlighted the need to focus on VRU safety. One avenue to achieve this goal is to include more visual VRU content in driver education materials.
