**Application Affected Dates**

The sales/use tax rate changes apply to:

- Original applications with a “fee due date” or “date of first operation” of January 1, 2024, or later.
- Transfer applications with a purchase date of January 1, 2024, or later.

**Background**

Legislation provided that as of January 1, 2005, and every January 1st thereafter, fee amounts will increase when a calculation using the California CPI for the prior year provided by the California Department of Finance is equal to or greater than \$0.50.

Assembly Bill 126 (Chapter 319, Statutes 2023) extended the collection of the Alternative Fuel and Technology fee and Air Quality fees until June 30, 2035.

Under an Interagency Agreement Contract, DMV acts as an agent for California Department of Fee and Tax Administration to collect sales or use tax when a vehicle or undocumented vessel is sold or transferred unless the transaction is specifically exempted from payment of the sales or use tax. The state, county, and/or city taxes are combined to determine the total sales/use tax rate due.
