When this vehicle is sold, complete a bill of sale and give both forms to the buyer, remove and destroy the vehicle's license plate(s), and within 5 days of sale, submit a completed Notice of Release of Liability (NRL) form to the department. All registration fees and penalties become due and payable on the lien sale date.
