Pursuant to CVC §41500, a driver license shall not be suspended or revoked, and the issuance or renewal of a driver license shall not be refused as a result of a pending non-felony offense occurring prior to the time a person was committed to the custody of a county jail pursuant to *Penal Code* (PC) §1170(h).

**GENERAL INFORMATION AND INSTRUCTIONS
REQUEST FOR DISMISSAL OF FAILURE TO APPEAR (FTA) VIOLATIONS FORM**

California Vehicle Code (CVC) §41500 allows the Department of Motor Vehicles (DMV) to remove eligible failure to appear (FTA) violations and terminate corresponding suspensions of violations that occurred prior to a person's incarceration date.

This form is only applicable for individuals incarcerated in a county jail due to a felony punishable pursuant to *Penal Code* (PC) §1170(h). This form does not apply to individuals whose current or most recent commitment to a county jail was due to a non-felony offense.

INSTRUCTIONS TO THE FACILITY

Complete the first page of this form in blue or black ink and mail the original copy to DMV at the address below. A county stamp or seal is required for DMV to accept and process this form.

When completing Section 2, provide the following information:

- All county jail incarceration dates due to a felony punishable pursuant to PC §1170(h).
- If applicable, check the box to indicate whether the type of commitment is new or a transfer from a different facility.
- If applicable, check the "Terms of Release Violation" box if the person was committed to a county jail for an offense that was committed while temporarily released from custody.
