Education

Incumbents must possess 12 semester or 18 quarter units course work in any combination of a <u>data driven research-related field</u>, <u>such as economics</u>, <u>mathematics</u>, <u>psychology</u>, <u>sociology</u>, <u>demography</u>, <u>geography</u>, <u>anthropology</u>, <u>statistics</u>, <u>data science</u> <u>or a research-related field</u>. <u>This must include at least one course in statistical methods</u>; **and**

Equivalent to graduation from an accredited college with a bachelor's degree. Work experience may be substituted on a year-for-year basis by applicants who have the required units mentioned above.

A Master's Degree in economics, mathematics, psychology, sociology, demography, geography, anthropology, statistics, data science or a related <u>research-oriented field</u> may be substituted for two years of the required experience. A doctoral degree in the same areas may be substituted for three years of the required experience.

Experience applicable to one of the following patterns may be combined on a proportional basis with experience applicable to the other pattern to meet the total experience requirements.

Either 1

One year in the California state civil service performing data <u>research-oriented duties in</u> <u>a class with a level of responsibility equivalent to that of Research Data Supervisor 1, or</u> <u>the Research Data Specialist 1;</u>

or 2

Experience: Five years of <u>professional data research-oriented experience which must</u> <u>have included responsibility for the determination of research data gathering and</u> <u>reporting design and methodology of a complete research project.</u> (Research experience applied toward this pattern must include at least one year of experience performing duties with a level of responsibility equivalent to Research Data Supervisor 1, or the Research Data Specialist 1.)

POSITION DESCRIPTION

Research Data Supervisor 2

Under general direction, this is the full supervisory level over analytical data research and administrative work. In most settings, incumbents supervise a well-established and fully developed research function. Incumbents spend majority of their time in supervision and management activities, rather than personally performing work which can be done by an analyst or Research Data Specialist.

EXAMINATION SCOPE

This examination consists of the following components:

Training and Experience Evaluation – Weighted 100% of the final score.

The examination will consists solely of a **Training and Experience Evaluation.** To obtain a position on the eligible list, a minimum score of 70% must be received. Applicants will receive their score upon completion of the Training and Experience Evaluation process.

In addition to evaluating applicants' relative knowledge, skills, and ability, as demonstrated by quality and breadth of education and/or experience, emphasis in each exam component will be measuring competitively, relative job demands, each applicant's:

Knowledge of:

- 1. Data analysis methods and techniques including gathering and collection of structured and unstructured data, as well as general principles, concepts and terminology used in research
- 2. Planning studies and investigations
- 3. Trend analysis procedures
- 4. Time management techniques to provide for efficient prioritization and completion of projects and assignments
- 5. Software to prepare spreadsheet summaries, reports, charts, and tables
- 6. Basic arithmetic and statistical techniques to analyze numerical data
- 7. Departmental policies and procedures
- 8. Design and implement research-related projects

- 9. Practices required to ensure and maintain data security, including securely transmitting confidential data
- 10. Experimental design procedures
- 11. Problem-solving techniques and processes to identify and resolve issues related to the completion of work assignments
- 12. Advanced mathematical techniques and descriptive statistical analysis techniques and methods
- 13. Principles and concepts applied in research and statistical settings
- 14. Principles and concepts appropriate to data and research techniques and methodologies

ELIGIBLE LIST INFORMATION

A servicewide, open eligible list for the **Research Data Supervisor 2** classification will be established for the State of California (all State of California departments, statewide).

The names of successful competitors will be merged onto the eligible list in order of final score regardless of exam date. Eligibility expires **12 months** after it is established. Applicants must then retake the examination to reestablish eligibility.

Veterans' Preference will be granted for this examination. In accordance with Government Codes 18973.1 and 18973.5, whenever any veteran, or widow or widower of a veteran achieves a passing score on an open examination, he or she shall be ranked in the top rank of the resulting eligible list.

If you meet the requirements stated on this examination bulletin, you may take this examination, which is competitive. Possession of the entrance requirements does not assure a place on the eligible list. Your performance in the examination described in this bulletin will be rated against a predetermined job-related rating, and all applicants who pass will be ranked according to their score.

The California Department of Human Resources (CalHR) reserves the right to revise the examination plan to better meet the needs of the service, if the circumstances under which this examination was planned change. Such revision will be in accordance with civil service laws and rules and all applicants will be notified.

General Qualifications: Applicants must possess essential personal qualifications including integrity, initiative, dependability, good judgement, the ability to work cooperatively with others, and a state of health consistent with the ability to perform the assigned duties of the class. A medical examination may be required. In open examinations, investigation may be made of employment records and personal history and fingerprinting may be required.

Eligible Lists: Eligible lists established by competitive examination, regardless of date, must be used in the following order: 1) sub-divisional promotional, 2) departmental promotional, 3) multi-departmental promotional, 4) servicewide promotional, 5) departmental open, 6) open. When there are two lists of the same kind, the older must be used first. Eligible lists will expire in one to four years unless otherwise stated on the bulletin.

High School Equivalence: Equivalence to completion of the 12th grade may be demonstrated in any one of the following ways: 1) passing the General Education Development (GED) Test; 2) completion of 12 semester units of college-level work; 3) certification form the State Department of Education, a local school board, or high school authorities that the competitor is considered to have education equivalent to graduation from high school; or 4) for clerical and accounting classes, substitution of business college work in place of high school on a year-for-year basis.
