**Automobile Dismantler Definition**

Pursuant to the California Vehicle Code (CVC) §220, an "automobile dismantler" is any person not otherwise expressly excluded by §221 who:

(a) Is engaged in the business of buying, selling, or dealing in vehicles of a type required to be registered under this code, including non-repairable vehicles, for the purpose of dismantling the vehicles, who buys or sells the integral parts and component materials thereof, in whole or in part, or deals in used motor vehicle parts. This section does not apply to the occasional and incidental dismantling of vehicles by dealers who have secured dealers plates from the department for the current year whose principal business is buying and selling new and used vehicles, or by owners who desire to dismantle not more than three personal vehicles within any 12-month period.

(b) Notwithstanding the provisions of subdivision (a), keeps or maintains on real property owned by him, or under his possession or control, two or more unregistered motor vehicles no longer intended for, or in condition for, legal use on the highways, whether for the purpose of resale of used parts, for the purpose of reclaiming for use some or all of the materials, whether metal, glass, fabric, or otherwise, or to dispose of them, or for any other purpose."

Pursuant to CVC §11504, the department shall obtain the following information for the purpose of licensure.

Consequently automobile dismantlers with a §5015 SIC Code must comply with these regulatory requirements.*

Only a Storm Water Permit will be accepted for application purposes. The Notice of Intent issued by the State Water Resources Control Board to obtain a Storm Water Permit will not be accepted for licensure purposes.

Department of Toxic Substance Control (DTSC) is one of six Boards and Departments within the California Environmental Protection Agency. The DTSC regulates hazardous waste in California specific to laws that affect hazardous waste applicable to handling, storage, transportation, disposal, treatment, reduction, cleanup and emergency planning. Consequently, essentially all business generators of hazardous waste in California must have a California ID Number.

A "generator" as defined in §66260.10 of Title 22, Division 4.5 of the *California Code of Regulations* (CCR) is any person, by site, whose act or process produces hazardous waste identified or listed in Chapter 11 of this division or whose act first causes a hazardous waste to become subject to regulation.
