3. **Disregard this notice** if you no longer own or want this vessel or vessel/trailer, so I can proceed with the sale. However, you may be held liable for my costs of removal and disposition of this vessel or vessel/trailer if you are the last owner of record.

If vessel was a police impound, a fair market value statement is not necessary.
