Section 423.00 – Fee Adjustment

§ 423.00. Fee Adjustment.

(a) Vehicle Code sections 1678 and 1685 require the department on January 1, 2005, and every January 1 thereafter, to adjust specified fees by increasing each fee in an amount equal to the increase in the California Consumer Price Index for the prior year, as calculated by the Department of Finance with amounts equal to or greater than fifty cents (\$0.50) rounded to the next highest whole dollar.

(1) Effective January 1, 2005, the following fees authorized under the following statutes shall be changed to:

(B) Twenty dollars (\$20) for fees authorized under Vehicle Code section 14901.

(C) Twenty-one dollars (\$21) for fees authorized under Vehicle Code section 14902(a).

(D) Twenty-five dollars (\$25) for noncommercial driver license fees authorized under Vehicle Code sections 12814.5(d), 14900(a), and 14900.1(a).

(E) Thirty-five dollars (\$35) for fees authorized for commercial driver license renewal or noncommercial firefighter driver license renewal under Vehicle Code section 12814.5(d).

(2) Effective January 1, 2006, the following fees authorized under the following statutes shall be changed to:

(A) Ten dollars (\$10) for fees authorized under Vehicle Code section 9250.8(a) and (b).

(B) Thirteen dollars (\$13) for fees authorized under Vehicle Code section 9250.13(a)(1) and (2).

(C) Twenty-six dollars (\$26) for noncommercial driver license fees authorized under Vehicle Code sections 12814.5(d), 14900(a) and 14900.1(a).

(D) Thirty-six dollars (\$36) for fees authorized for commercial driver license renewal or noncommercial firefighter driver license renewal under Vehicle Code section 12814.5(d).

(3) Effective January 1, 2007, the following fees authorized under the following statutes shall be changed to:

(A) Six dollars (\$6) for fees authorized under Vehicle Code sections 14900(b) and 14900.1(b).

(B) Seven dollars (\$7) for fees authorized under Vehicle Code section 9250.13(a)(1) and 14902(c).

(C) Fourteen dollars (\$14) for fees authorized under Vehicle Code section 9250.13(a)(1) and (2) for Commercial Vehicle Registration Act (CVRA) vehicles only.

(D) Seventeen dollars (\$17) for fees authorized under Vehicle Code sections 4604(b), 5014(f), 5036, 6700.25(e), 9102.5(a), 9102.5(c), 9252(a), 9254, 9258, 9261(a), 9261(b), 9261(c), 9261(d), 9265(a), 9265(b), 9702, 11515, 11515.2, 38121(b), 38232, 38255(a), 38255(b), 38255(c), 38260, and 38265(a); Code of Civil Procedure sections 488.385(b) and (c); Revenue and Taxation Code section 10902(c).

(E) Twenty-one dollars (\$21) for fees authorized under Vehicle Code section 14901.

(F) Twenty-two dollars (\$22) for fees authorized under Vehicle Code section 14902(a).

(G) Twenty-seven dollars (\$27) for noncommercial driver license fees authorized under Vehicle Code sections 12814.5(d), 14900(a) and 14900.1(a).

(H) Thirty-eight dollars (\$38) for fees authorized for commercial driver license renewal or noncommercial firefighter driver license renewal under Vehicle Code section 12814.5(d).

(4) Effective January 1, 2008, the following fees authorized under the following statutes shall be changed to:

(A) Twenty-two dollars (\$22) for fees authorized under Vehicle Code section 14901.

(B) Twenty-three dollars (\$23) for fees authorized under Vehicle Code section 14902(a).

(C) Twenty-eight dollars (\$28) for noncommercial driver license fees authorized under Vehicle Code sections 12814.5(d), 14900(a) and 14900.1(a).

(D) Thirty-nine dollars (\$39) for fees authorized for commercial driver license renewal or noncommercial firefighter driver license renewal under Vehicle Code section 12814.5(d).

(5) Effective January 1, 2009, the following fees authorized under the following statutes shall be changed to:

(A) Four dollars (\$4) for fees authorized under Vehicle Code sections 1685(d), 38225.4 and 38225.5.

(B) Eleven dollars (\$11) for fees authorized under Vehicle Code sections 9250.8(a) and (b).

(C) Eighteen dollars (\$18) for fees authorized under Vehicle Code sections 4604(b), 5014(f), 5036, 6700.25(e), 9102.5(a), 9102.5(c), 9252(a), 9254, 9258, 9261(a), 9261(b), 9261(c), 9261(d), 9265(a), 9265(b), 9702, 11515, 11515.2, 38121(b), 38232, 38255(a), 38255(b), 38255(c), 38260, and 38265(a); Code of Civil Procedure sections 488.385(b) and (c); and Revenue and Taxation Code section 10902(c).

(D) Twenty-four dollars (\$24) for fees authorized under Vehicle Code section 14902(a).

(E) Forty dollars (\$40) for fees authorized for commercial driver license renewal or noncommercial firefighter driver license renewal under Vehicle Code section 12814.5(d).

(6) Effective January 1, 2010, the following fees authorized under the following statutes shall be changed to:

(A) Twenty-five dollars (\$25) for a duplicate or name change of a noncommercial Class C or M driver license, under Vehicle Code section 14901.

(B) Thirty-one dollars (\$31) for a noncommercial renewal by mail Class C or M driver license under Vehicle Code section 14900.1(a).

(C) Thirty-one dollars (\$31) for an original noncommercial Class C or M driver license, under Vehicle Code section 14900(a).

(D) Thirty-one dollars (\$31) for a noncommercial renewal in person or to change license classification of a noncommercial Class C or M driver license, under Vehicle Code section 14900.1(a).

(E) Forty dollars (\$40) for a commercial Class C driver license renewal under Vehicle Code section 15255.1.

(F) Forty dollars (\$40) for a noncommercial firefighter driver license renewal under Vehicle Code section 15250.6(e).

(7) Effective January 1, 2011, the following fee authorized under the following statutes shall be changed to:

(A) Nineteen dollars (\$19) for fees authorized under Vehicle Code section 9250.13(a)(1).

(8) Effective January 1, 2013, the following fees authorized under the following statutes shall be changed to:

(A) Thirty-two dollars (\$32) for noncommercial driver license fees authorized under Vehicle Code sections 14900(a) and 14900.1(a).

(B) Twenty-six dollars (\$26) for a duplicate or name change of a noncommercial Class C or M driver license under Vehicle Code section 14901.

(C) Twenty-seven dollars (\$27) for fees authorized under Vehicle Code section 14902(a).

(D) Sixty-eight dollars (\$68) for an original commercial driver's license authorized under Vehicle Code section 15255.1(a).

(E) Forty dollars (\$40) for fees authorized under Vehicle Code section 15255.1(b) and (c),

(F) Thirty dollars (\$30) for a duplicate commercial driver's license, authorized under Vehicle Code section 15255.2.

(G) Nineteen dollars (\$19) for fees authorized under Vehicle Code sections 4604(b), 5014(f), 5036, 6700.25(e), 9102.5(a), 9102.5(c), 9252(a), 9254, 9258, 9261(a), 9261(b), 9261(c), 9261(d), 9265(a), 9265(b), 9702, 11515, 11515.2, 38121(b), 38232, 38255(a), 38255(b), 38255(c), 38260, and 38265(a), Revenue and Taxation Code section 10902(c), and Code of Civil Procedure sections 488.385(b) and (c).

(I) Four dollars (\$4) for fees authorized under Vehicle Code section 9250.8(a).

(C) Twenty-eight dollars (\$28) for an identification card regular authorized under Vehicle Code section 14902(a).

(D) Seventy dollars (\$70) for an original commercial driver license, authorized under Vehicle Code section 15255.1(a).

(E) Forty-one dollars (\$41) for renewal of a commercial driver license authorized under Vehicle Code section 15255.1(b) and (c).

(F) Thirty-one dollars (\$31) for a duplicate commercial driver license, authorized under Vehicle Code section 15255.2.

(G) Twenty dollars (\$20) for California Highway Patrol fees authorized under Vehicle Code section 9250.13(a)(1).
