

Notice of Modification of Proposed Regulations
Title 13 – Motor Vehicles
Article 3.6 –Interstate Carrier Program

March 27, 2019

Pursuant to the requirements of Government Code section 11346.8(c), and section 44 of Title 1 of the California Code of Regulations, the Department of Motor Vehicles is providing notice of changes made to the proposed regulations. These changes are in response to feedback received from the Office of Administrative Law.

Only comments on the changes proposed in this Notice will be considered by the department. Pursuant to Government Code section 11346.8(c), comments that are not regarding the proposed changes will not be responded to in the final statement of reasons.

Attached is the full text of the proposed regulation. The text includes the originally proposed language, as well as the new proposed changes to the proposed regulation. The language modifications are clearly illustrated by the following methods:

- (1) The language originally proposed to be added to the text is single underlined.
- (2) The language proposed to be added is double underlined.
- (3) ~~The language proposed to be deleted is double overstruck and single underlined.~~
